	Long Term Unemployed-Self Attestation <ul style="list-style-type: none"> <input type="checkbox"/> Has a substantial employment history (i.e., at least 12 months of full-time or 24-months of part-time work experience), is currently unemployed, and has been unemployed for at least 15 of the past 26 weeks <input type="checkbox"/> Is currently unemployed and has been unemployed for at least 15 of the past 26 weeks <input type="checkbox"/> Is currently employed but had been unemployed for 15 of the past 26 weeks and is not currently self-sufficient based on local policy; or <input type="checkbox"/> Is either currently unemployed or working part-time, has not worked over 30 hours per week in any 15 of the past 26 weeks, has been seeking but unable to secure full-time employment, and is not currently self-sufficient based on <input type="checkbox"/> local policy
	Terminated or laid off (if UCRS eligible, only have to document REA selection. 	Displaced homemaker <ul style="list-style-type: none"> <input type="checkbox"/> Providing unpaid work in the home who is unemployed or underemployed and has been dependent on the income of another family member but is no longer supported by that income.
	Military Spouse <ul style="list-style-type: none"> <input type="checkbox"/> Spouse of active-duty Armed Forces who experienced a loss of employment from relocation. <input type="checkbox"/> Spouse of armed forces as a displaced worker.
